**SUBJECT:** Final Budget for Fiscal Year 2023-24

### **BACKGROUND**

Local Agency Formation Commissions (LAFCos) are responsible for annually adopting a proposed budget by May 1<sup>st</sup> and a final budget by June 15<sup>th</sup> in accordance with Government Code Section 56381. State law specifies the proposed and final budgets shall, at a minimum, be equal to the budget adopted for the previous fiscal year unless LAFCo finds the reduced costs will nevertheless allow the agency to fulfill its prescribed regulatory and planning duties.

#### DISCUSSION

The Proposed FY 2023-24 Budget that was approved by the Commission at the April 18, 2023 regular Commission meeting was sent to all participating member agencies including Trinity County for review and potential comment. To date, one comment was received on the proposed budget (see attached email correspondence).

#### **Funding Sources:**

Trinity LAFCos annual operating expenses are principally funded through appropriations from the County and Special Districts, in addition to application fees. Each fiscal year, after the Commission adopts the final budget, the County Auditor apportions operating expenses between the County and the independent special districts. Statutory authority allows the County Auditor to collect the amounts apportioned.

#### Operating Expenses:

The proposed operating expenses reflect the anticipated staffing services, daily operational needs, and preparation of municipal service reviews and sphere of influence updates. No changes in operating expenses are proposed from the prior fiscal year.

#### **Operating Revenues:**

An approximate 3% increase to contributions from local funding agencies in Fiscal Year 2023-24 is proposed to reduce reliance on reserves needed to balance the operational budget. At the April 18 LAFCo meeting, the Commission discussed the need to address the budget shortfall to avoid exhausting reserves in coming years.

### **Proposed Work Plan:**

As stated above, the proposed budget is intended to cover basic operating and administration expenses of the commission. This includes the development of municipal service reviews and

sphere of influence updates for special districts throughout the county. As part of the Fiscal Year 2023-24 budgeting process, staff is proposing the following work plan:

# ADOPTING A FINAL BUDGET FOR FISCAL YEAR 2023-24

**WHEREAS**, the Trinity Local Agency Formation Commission is required by the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 to adopt a final budget for the next fiscal year no later than June 15; and

**WHEREAS**, the Executive Officer prepared a report concerning the proposed budget, including recommendations thereon; and

**WHEREAS**, the Executive Officer's report was presented to the Commission in the manner provided by law; and

**WHEREAS**, the Commission heard and fully considered all the evidence presented at its public hearing on the proposed budget held on June 20, 2023; and

**WHEREAS**, the Commission determined the final budget projects staffing and program costs of the agency as accurately and appropriately as is possible.

## NOW THEREFORE, IT IS RESOLVED, DETERMINED AND ORDERED as follows:

- 1. The final budget for Fiscal Year 2023-24 as outlined in Exhibit A is hereby approved and by this reference incorporated herein:
- 2. The overall operating costs provided in the proposed budget will allow the Commission to fulfill its regulatory and planning responsibilities as required under Government Code Section § 56381(a);
- 3. The final budget for Fiscal Year 2023-24 shall be submitted to the County Controller in order to make appropriations to the County and Special Districts in accordance with Government Code Section §56381(b).

Hi Sally,

Thanks for reaching out. Collectively, special districts in Trinity have representation on LAFCo which is important. Our budget is principally funded by the county (pays 1/2 of the net operating costs) and special districts (as a whole pays 1/2 of the net operating costs). The special district apportionments are collected by the County Auditor-Controller based on a formula that charges bigger districts more and smaller districts less. We try to keep member apportionments to a minimum while making slow but meaningful progress on preparing Municipal Service Reviews and Sphere of Influence Updates for each district in the county. With only \$15,000 per year allocated to MSRs, we are only able to complete a couple per year. I started providing Executive Officer services in 2019-20 and recognize that the Commission is behind on preparing MSRs but we are diligently trying to catch up. We are currently prioritizing fire districts since they are largely volunteer and may have opportunities to pursue annexation of existing out-of-district goodwill response areas and establish sustainable ongoing funding. We also want to prioritize districts that may need changes to their existing Sphere of Influence, which is an important precursor to annexation. Ultimately, we will be preparing a MSR/SOI Update for the Hayfork Valley Park and Recreation District, although we do not have a date certain.
